#### **IMPORTANT INFORMATION**

This Kickball Tournament will be played according to the attached rule sheet. Please initial the following to acknowledge your team understands that the following rules be adhered to:

\_\_\_\_\_I understand that each team must field a roster of at least 10 players and 10 players must be on the field at all times. Attendance of the tournament with less than the prescribed number of participants will result in automatic forfeiture of the tournament and my team will not be able to compete. Players not listed on the roster will not be allowed to play.

\_\_\_\_I understand that each team is advised to have at least 4 females listed on the roster—with 4 females on the field at all times during regulation play. If my team chooses to forego adherence to this rule, we understand it will result in an automatic out and my team will play one player short.

\_\_\_\_\_I understand that alcohol IS ALLOWED in the parking lot, stands, and around the fields of the grounds (The Northern Little League Fields). Alcohol is NOT allowed in the dugouts or on the fields at any point of time throughout the tournament. If anyone at any time a volunteer or ref feels you are being too aggressive or out of hand due to alcohol you will be asked to leave immediately.

\_\_\_\_I understand that profanity, excessively aggressive and abusive language to other players, referees, tournament staff and spectators will not be tolerated. The first violation of this rule will result in a verbal warning to the player and team. A second violation of this rule will result in the immediate disqualification of the player in question.

\_\_\_\_I understand that our team may only have up to TWO (2) coaches listed on our roster and non-playing coaches must stay within the approved Coach areas during regulation play.

\_\_\_\_\_I understand that players must stay in the designated team bench/sideline area when they are not kicking or on-deck to kick.

\_\_\_\_\_I understand that each player individually will have a 2 strike rule on behavior before being ejected and each team as a whole will have a 3 strike rule on behavior before being ejected.

\_\_\_\_\_I understand a violation of any of the attached rules (even if not expressly mentioned in this list for initialing) will result first in a warning to the player/coach in question. A second violation will be cause for ejection from the tournament at the discretion of tournament staff.

\_\_\_\_I understand there will be a coaches meeting on Oct. 3rd, at 5:30 P.M. at HASA and the coaches attendance is Mandatory.

# INTRODUCTION

These rules serve to promote that spirit of fairness, sportsmanship, and fun. The Rules Committee requires all coaches, captains, players, referees and fans to conduct themselves in a professional manner before, during and immediately following all games.

#### SPIRIT OF THE GAME

This kickball tournament in general relies upon a spirit of sportsmanship that places the responsibility for a fair and fun tournament. The purpose of this event is to serve as a fund raiser for the Housing Solutions Department

of the Housing Authority of San Angelo. This Department supports a Basic Needs Closet, located at 2621 Junius. The proceeds of this event will assist in providing food, clothing, hygiene products and even furniture for those in need. We realize this is also about the love of the game and we recognize highly competitive play is going to happen, but it should never be at the expense of mutual respect among competitors, adherence to the agreed upon rulebook, or the basic joy of play.

We encourage all Players and Referees to protect the spirit of the game and to strive to eliminate unsportsmanlike conduct from the field. Such actions as taunting opposing players, dangerous aggression, belligerent intimidation, intentional infractions, or other 'win-at-all-costs' behavior are contrary to the Spirit of the Game and must be avoided by all players.

In the event the letter of the rules can be interpreted in a manner that conflicts with the spirit of this tournament, we reserve the right to protect the integrity and intent of this event.

#### SPIRIT OF THE RULES

Players and Referees are encouraged to obey the rules but acknowledge the spirit, whereas a Player may be obeying the literal interpretation of the words of the rule, but not necessarily the intent of the rule. In the event the letter of the rules can be interpreted in a manner that conflicts with the spirit of the entire rule-book, referees reserve the right to protect the integrity and intent of this tournament.

#### SPIRIT OF THE TOURNAMENT

The staff of the Housing Authority of San Angelo appreciate your support and willingness to honor the spirit of this event. We believe in our mission and our part in the community effort to make a positive impact in our neighbors lives. We hope to make this event an annual occurrence and hope that you enjoy playing in this tournament. The spirit of this tournament is a fun, competitive, team building event to raise funds to support the Housing Solutions team at HASA.

#### FEEDBACK ON THE EVENT

This being only our second Kickball Tournament, we appreciate your patience and willingness to work with us to make this a successful annual event. #### Incase Of Bad Weather

The game will be called in the event of inclement weather that leaves the field condition unplayable. HASA will attempt to reschedule any canceled games. If a game is called due to weather and less than 3 complete innings have been played, the game is canceled and will be rescheduled (and replayed starting at 0-0, top of the 1st). If 3 or more full innings have been played, the final score will be the score at the end of the last complete full inning.

# **Kickball Tournament Rules**

Team Size:

- 10-15 People per team
- Roster must be co-ed (MINIMUM of four females)
  - If an injury occurs at the tournament or an emergency means a female cannot participate these will be the alternative rules to follow. (When registering the day of there must still be AT LEAST 4 females present):
    - only 2 females, play one man down in field and take an out at bottom of line up. Only 1 female, then play two men down and 2 outs
    - you are allowed to have a sub fill in for a female who cannot play due to reasons as stated above. However, the Sub must also be female and must arrive at the tournament with the team and be listed as a sub on the registration form.
- Only 10 people on the field at once for defense
- Entire Roster must be in a kicking order

#### Kicking:

- Must stay in same kicking order (kicking order cannot change in game)
- Kickers contact with ball must be made at or behind the plate. Will result in a foul ball is kicked in front of plate. If kicked above the knee, it is a foul ball
- 3 strikes and you're out
- Missed kick is a strike
- Foul ball is a strike-definition of foul ball below
  - Kicked ball landing in foul territory
  - Kicked ball touched in foul territory
  - Kicked ball landing in fair territory but touching foul territory on its own at any time before reaching first or third base
- You can get out on a foul ball
  - 4 balls are a walk and 3 strikes is an out (all fouls are counted as strikes
    - The strike zone includes the plate, plus 1 foot on either side and maximum height of 1 foot
  - Bunting is only allowed if the ball makes it past the baseline, otherwise it is considered a foul
- Any attempt at a kick is a kick

#### Game Length:

- 45 min or 5 innings
- No new innings started with 5 minutes left.
- Referee will give alert at 10- and 5-minute mark
  - If 10 runs are scored in an inning, inning is over
  - By the 3<sup>rd</sup> inning, if either team is up by more than 10 runs, the game will be called.

# <u>Outs</u>

- If the ball is caught in the air without touching the ground first, then the batter is out (a fly out)
- A defensive player with the ball touches the base ahead of a runner who is forced to go to that base, because of advancing runner behind them (a force out)
- A defensive player touches the runner directly with the ball while holding it (a tag out)
- A defensive player may throw the ball and hit the runner on the fly with it (no hitting runner above shoulders) if you do, then the runner will advance one base further than the one they were running to
- No headshots or feet shots (on purpose), these shots will not count as an out
- If a throw goes outside the field of play, each base runner moves up one base

#### <u>Fielding</u>

• The defense consists of a Pitcher, catcher, 1B, 2B, SS, 3B and 4 outfielders

- Outfielders must stay off the infield until the ball is pitched
- Infielders must be behind the first 1<sup>st</sup> to 3<sup>rd</sup> diagonal until the ball is pitched
- Catcher must be at least 3 feet behind the plate
- Infield fly rule is in place: player may NOT intentionally drop a catch-able ball in an attempt to complete a double play. Any fly ball within the infield deemed as easy catch with less than 2 outs and runners on 1<sup>st</sup> and 2<sup>nd</sup>, or 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>. If the referee observes this, then all players are safe at their next base, including the kicker running to 1<sup>st</sup> base
- If a fielder interferes with a base runner in the baseline, the base runner safely advances to the base they were approaching
- Fielders making a play on a base must lean out of the baseline when making a play on the bag. If a fielder is standing on the base, the runner will be safe if he/she mees to avoid a collision at the base
  - Fielders MUST stay BEHIND or to the OUTSIDE of the base when an opposing player is running to it.

#### Scoring & Advancement

• If the home team already leads the game when the bottom of the final inning is reached, that team wins the game instantly and the game is over. If the home team takes the lead during the bottom of the final inning, that team wins instantly and the game is over. If an extra inning is needed, teams will start their at-kick with the next kicker in the lineup on 2<sup>nd</sup> base, 1 out and each kicker starts with 2 balls in the count. First team to have a higher run total at end of a full extra inning wins.

#### <u>Tie</u>

- In case of a tie, a coin toss will be conducted by referee. Team that kicked first will call
- Tie games will go into extra inning with a runner on 2<sup>nd</sup> base

#### Semi-Finals and Championship Game

#### Miscellaneous Rules

- Pitches must be rolling, not bouncing
- A runner cannot force the ball to hit their head
- There are only in the park homeruns, ie. No homerun over fence
- 6 run max per inning except last inning
- NO leading or stealing off base until the ball has been kicked, or intentional walking
- Runner leaves on kicker's contact
- NO sliding into home or 1<sup>st</sup>. NO head first sliding (except when base is overrun)
- ONLY CAPTAINS CAN ARGUE A CALL. If someone disagrees on a call, they can pause game and discuss it with their captain and the captain may take it to the ref.
- NO COMPLAINING. There is only one referee per game-please respect calls of official. ALL CALLS ARE FINAL
- There will be one ref assistant on the field for each game.
- If a game is a blowout, the game after can move ahead if BOTH coaches agree

#### Coaches Meeting

A MANDATORY Coaches meeting will be held at the Housing Authority of San Angelo, **420 E. 28th St. at 5:30 P.M on October 3rd.** The purpose of the meeting will be to review the rules provided and answer any questions you may have regarding the tournament. The meeting will be for coaches and referees. If a coach cannot attend the meeting, please have another representative from your team be in attendance.

# **ENFORCEMENT & DISCIPLINARY**

Event Manager(s), the Event Head Referee-in-Charge, or any appointed individual or group charged with decision-making regarding conduct may issue Warnings, Cards, and/or Ejections for violations of these rules and/or other unsportsmanlike behavior.

Players are expected to behave in a manner consistent with the mission of the organization while (a) on the playing field, (b) interacting with the administration and officers and (c) dealing with the greater community. The same expectations exist for teams and other groupings of players.

No lower level of Enforcement is required to precede a higher level of Enforcement. A Game Head Referee may directly issue higher-level Enforcement, at their discretion.

# **DISCIPLINARY ACTIONS**

At the time of issuing a disciplinary action the Game Head Referee must notify all Game Referee(s), and both Team Captain's of such instance.

If a warning is issued to a Player, Team Captain, Non-Playing Coach, and/or Fan, then the Game Head Referee must document the Name, level of warning, and reason at time of card being issued.

Prior to all games, the Game Head Referee must be notified of Players, Visitors, or Fans who have already received Enforcement under "Disciplinary Levels"

## DISCIPLINARY LEVELS

## Warnings (Lowest-Level Enforcement)

Player will receive a Warning for committing any of the following towards another Player, Referee, Visitor, or Fan in attendance. The following actions are examples only and are not a complete list: taunting; physical/verbal abuse; excessively delaying play; entering the field of play without the Game Head Ref-eree's permission; deliberately leaving the field to delay the Game; stalling; colluding; inappropriately discussing of calls with the Referees/Event Staff; making an improper Substitution as described; repeatedly failing to comply with instructions of Referees and/or Event Staff concerning Rules and Game Play; engaging in any activity otherwise prohibited by the Event Facility rules, or local/state/federal law; and/or engaging in other unsportsmanlike behavior, as determined by the Game Head Referee.

Players will not receive a second Warning in the same Game for a related infraction. The minimum sanction for such a Player will be a warning.

## 2nd Warning (Mid-Level Enforcement)

Player will receive a 2nd warning for committing any of the following towards another Player, Referee, Visitor, or Fan in attendance. The following actions are examples only and are not a complete list: Commits a reckless manner (for example, charging, pushing, tripping), commits a tactical foul designed to interfere with or impede an opposing team (e.g., pushing an opponent, blatantly holding an opponent or an opponent's uniform), commits an act which, in the opinion of the Game Head Referee, shows a lack of respect for the game (e.g., aggressive attitude, inflammatory behavior, slamming equipment, or taunting), fakes an injury or exaggerates the seriousness of an injury, interferes with or prevents the Fielder from releasing the kickball from the hands into play, and/or verbally distracts an opponent during play, etc.).

Player will receive a 2nd warning for a serious instance of conduct described in that, in the discretion of the Game Head Referee, requires stronger enforcement.

Any Player receiving a 2nd warning in a game will not receive the courtesy of a Warning for a subsequent infraction. The minimum sanction for such a Player will be ejection from the game

## **3rd Level Warning (Final)**

A Player will receive a 3rd level warning for a particularly egregious instance of conduct described, for repeated instances of mis-conduct, or for fighting, extreme verbal abuse, lewd or obscene behavior, threatening behavior, and/or offensive language or comments.

Any Player receiving a 3rd warning in any Game will not receive the courtesy of a Warning or Yellow Card for any infraction in any subsequent Game.

The minimum sanction for such a Player will be ejection from the game/event.

This player must leave the vicinity of the Event and the area immediately. They Cannot be replaced on the Kicking Lineup by a bench player of the same sex. That player's spot in the Kicking Lineup now becomes an automatic out for that Team. They cannot be replaced by a substitute in the Defensive Fielding Lineup, forcing their team to play a player fewer of the player's same sex who was removed (e.g. Teams must play with nine (9) Defensive Fielders vs ten (10) Defensive Fielders OR seven (7) Defensive Fielders instead of eight (8) Defensive Fielders ).

Teams entering COT are not eligible to add a player of the same sex to their Defensive Fielder position to replace the ejected player.

That Player will not be considered as being lawfully on the premises.

Failure of an ejected player to leave the premises of the facility will cause that player's team to forfeit any game it has progress in.

Visitors and Fans engaging in egregious instance conduct described above will be issued a 3rd warning and subjected to removal from vicinity of the event.

\*\*\* This year HASA is adding an "aggression jar" (similar to the swear jar concept). An aggression jar will be available in the dugouts, if you or your team do become aggressive or rowdy during the game, a donation to the cause is appreciated.
